It should be clear that the first change will give membership a more direct voice in both the election of the President and the overall direction of AROSC affairs. And, that kind of direct participation has always made for more healthy and viable organizations. The second change is also desirable, since the original AROSC By-Laws prohibited individuals with an interest in the sale of Alfa Romeo automobiles from serving on the AROSC Board of Directors. Experience has shown that such a measure is not necessary, and in fact can limit the service of otherwise qualified persons. Publication of Board Minutes, and other public scrutiny of Board operations both offer sufficient protection to the overall Club interests.

OIL RACING By-- J Samson

The grey fog bank floated across the ert floor towards the serpentine phalt ribbon called Riverside Raceway. It finally shrouded the track as a curtain covers the stage of a theatre before a drama is to unfold. And truly a drama was to take place as the day progresseda mixture of tragedy, humor, suspense and finally victory.

As the sun raised the foggy curtain, the overture of blating engines signaled the play was ready to start. The stage had been set, the props carefully placed at the turns and the players were in costume For the first time the sweeping team was not needed to prepare the track--little did we know how they would be needed later. The eight novice drivers had completed their orientation and at 9:30 am the first practise session was flagged off. Within 20 minutes tragedy will have struck at turn 2. Tom Hines, driving the Vegher GTA, flipped nose to tail demolishing the aluminum racer and fortunately sparing Tom any harm. A line of oil extended from turn 1 to turn 2 when the crash occured. While a group of drivers muscled the "aluminum ball" on a trailer, the faithful sweepers started the first of many clean-up jobs. Two bags of cement and 20 minutes later the oil was covered and practise restarted. The group l session finished without further incident. he second practise group, composed of

e faster cars, was flagged off at 11:25 am. After 35 minutes, more excitement-Dale Jones laid a strip of oil from turn 6 Jim's coupe posting a new class A record to turn 8 as an oil cooler hose disconnected and T.T.O.D. Bill Kohl, driving a class Dale Jones laid a strip of oil from turn 6 Before a crew could be dispatched, Charlie, B spider, finished second in the section Thieriot blew off the oil filter from the Alfetta power plant in turn 8 and repaved the track with 20-50w all the way to turn 7B. With the track covered with oil from turn 6 to turn 7B straight junction the red flag came out as did the cement and broom boys. This seemed like a good point to call 'time' and have a lunch break. The Harmon and Samson Boys returned like grey ghosts as they were covered with cement powder from head to toe. In the process of driving back from turn 8 an

open bag of cement was left on the tailgate of Carol Samson's 'family bus', (alias AROSC Emergency Vehicle). The interior was now redocorated in powder grey, not a significant improvement.

Fortunately, Carol was so busy making sandwiches and preparing the timing equipment the full impact of the redocoration didn't hit here. (It did later!)

The timed runs started only 30 minutes late despite the morning's 'fun'. When the first section was done Don Jaharis was holding top time of day and had it through the entire first group session. The ladies 'race' which had been hard fought all season went to Karen Cannone who bested Phyllis Gaylord by 0.78 sec. Kathy Rice was off her usual firm and finished a distant 3rd. At the half way point new records were set in classes Ew by Karen Cannone, G by Rich Settle (Alfetta), and F by Don Jaharis. Jerry Wright, novice racer but pro newsletter editor, held the class G record for 25 minutes; then the Alfetta sedan of Rich Settle snatched it from him.

The workers changed and the second group was ready to go.

After the first section the class G record was now held by C Thieriot driving the Alfetta sedan -- he bested R Settle's time by 6.29 seconds. Lou Dowdy now held T. T. O. D. out driving Jaharis by 1.7 sec. The next section contained the next to last duel between the Neuman and Samson GTV's, a duel that has extended all season through IMSA races, SCCA Solo I's and AROSC T.T.'s. The Samson GTV out ran winning class B and assuring himself the 1975 AROSC T.T. Championship. The next flight proved to be the closest of the day; Joe Cannone nipped Don Swears by 0.04 seconds to win class E. The final heat of the day was a real barnstormer. Steve Kohl and Bob Barlow put on a duel that saw Bob end up in the dirt on turn 8, while Steve went on to win class C.

As the sun snuggled into the grey blanket of haze and fog Bill Kohl launched the Champagne cork high into the air and

shared his liquid prize for being the 1975 T. T. Champion with all who wanted some. The beautiful trophies, provided by Parkinson VW-Alfa, were packed away by the winners. Five drivers received their AROSC T. T. licenses: Art Canning, Lou Dowdy, Fred Zimmerman, Jerry Wright and Merrit Carden.

The event was truly an overall success; the club made a few dollars, the emergency crews showed they could work under stress, the entry was the largest, second only to Alfa Pacifica, and we had teams not only from the San Diego Chapter but the Nor-Cal region also.

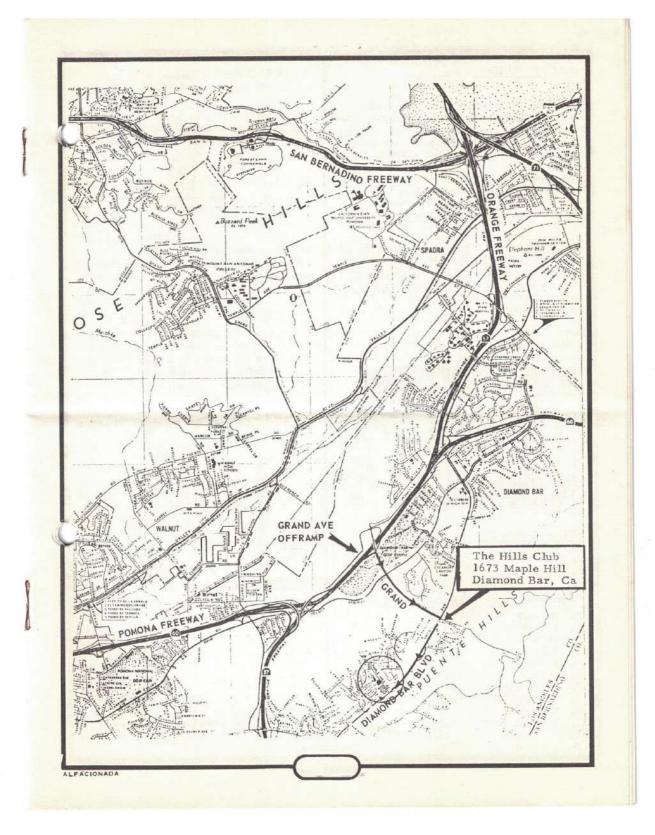

WATERLOGGED HUBCAPS By Les Hurlock

During the rainy season, this Alfaholic was horrified to find a quarter cup of water in each new-style hubcap of his wife's Duet o.

Most hubcaps have some form of drainage system, but these have none.

Small holes could be drilled in the hubcap outer flange, but (a) they are stainless steel and therefore hard to drill, and (b) the water would throw out over the front wheel surface.

The Alfaholics' way is to drill four 3/16 inch holes in the wheels themselves, as shown in the drawings. These small equally-spaced holes cannot weaken the wheel, or affect the balance They are easy to drill, and any water will be thrown off inside the wheel.



- (1) Locate and drill four equallyspaced 3/16 inch holes just on the inside edge of the scuffmark left by the outer rim of the hubcap (Fig. 2).
- (2) Countersink all holes (from the front only).
- (3) Finish off the holes with a little silver paint to stop them from rusting.
